**TO AMEND THE ORDINANCES THAT FIX THE
SALARIES FOR THE POLICE AND FIRE DEPARTMENTS
(ORDINANCE 96-24)
AND THE SALARIES FOR APPOINTED OFFICERS AND EMPLOYEES
(ORDINANCE 96-33)
FOR THE YEAR 1997**

Re: The Fire Department and the Department of Housing and Neighborhood Development

NOW BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. From and after January 1, 1997, the following position be added to Category 2 of the Professional & Command Classifications located in Section I of Ordinance 96-24, which, in particular, fixes the salaries of the officers Fire departments for the City in 1997:

FIRE DEPARTMENT

Professional & Command Classifications:

Category 2 = Headquarter Captain

SECTION 2. From and after January 1, 1997, the following classified positions, salaries and pay schedules be deleted from or incorporated into Section I of Ordinance 96-33, fixing the salaries and pay of Appointed Officers and Employees of the City in 1997, as indicated below:







SYNOPSIS

This ordinance amends two ordinances that fix salaries for officers and employees of the City for 1997. Section one amends the salary ordinance affecting the Fire Departments (Ord 96-24) by adding "headquarters captain" as a Category 2 - Professional and Command Classification. Section two amends the salary ordinance affecting the Redevelopment and Code Enforcement Departments (Ord 96-33) by reflecting the new positions and titles resulting from the consolidation of these departments.
