

**ORDINANCE 97-17**

**TO AMEND TITLE 15 OF THE BLOOMINGTON MUNICIPAL CODE ENTITLED  
"VEHICLES AND TRAFFIC"  
(Amending Provisions Regarding Stop Intersections, Restricted Turns on Red Lights,  
Limited, No Parking and Loading Zones, and Riding Bicycles on Sidewalks; and, Also  
Amending Ordinance 96-50)**

WHEREAS, on December 4, 1996 the Common Council adopted Ordinance 96-50 which contained a typographical error in need of correction; and

WHEREAS, the Traffic Commission has considered the above and other matters, and has recommended the following changes be made in Title 15 of Bloomington Municipal Code, entitled "Vehicles and Traffic";

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, THAT:

SECTION I. Section 15.12.010 Schedule A shall be amended to delete the following:

SECTION II. Section 15.12.010 Schedule A shall be amended to add the following:

SECTION III. Ordinance 96-50 be amended by striking the word "delete" as it appears in Section II and substituting the word "add". This amendment shall have the effect of adding the following to Section 15.12.010 Schedule B of the Bloomington Municipal Code:

SECTION IX. Section 15.32.100 Schedule O shall be amended to add the following:


LOADING ZONES

100 Block of Fourth Street 78' west of Walnut Street to 100' west of Walnut Street on the north side


SECTION X. Section 15.56.020 Riding on sidewalks shall be amended to delete the word "adius" and to substitute the word "diameter".

SECTION XI. This ordinance shall be in full force and effect on and after its passage by the Common Council and approval by the Mayor.





#### SYNOPSIS

This ordinance amends Title 15 of the Bloomington Municipal Code. The ordinance also corrects an error contained in a previous traffic ordinance.
