**ORDINANCE 97-51**

**TO AMEND TITLE 15 OF THE BLOOMINGTON MUNICIPAL CODE ENTITLED  
"VEHICLES AND TRAFFIC"  
(Stop, Yield, and Signalized Intersections; School/Park & Playground Speed Zones;  
Destination Truck Routes; and Parking Regulations)**

WHEREAS, the Traffic Commission has recommended certain changes be made in Title 15 of the Bloomington Municipal Code, entitled "Vehicles and Traffic";

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, THAT:

SECTION I. Section 15.12.010 Schedule A shall be amended to delete the following:


Dunkirk Square -- the first space west of Dunn Street on the south side of Kirkwood (Fifth) Avenue.

Fourth Street -- the first space west of Dunn Street on the south side.


Indiana Avenue -- the first space north of Fourth Street on the west side.

SECTION XIII. This ordinance shall be in full force and effect on and after its passage by the Common Council and approval by the Mayor.


