

ORDINANCE 96-21

**TO AMEND TITLE 15 OF THE BLOOMINGTON MUNICIPAL CODE
ENTITLED "VEHICLES AND TRAFFIC"**

Re: Adding Showers Center Municipal Lots 12, 13 & 14; Moving City Hall Employee Lot; Setting Lot Fees for 1997-1999; and, Reassigning Administrative Duties

WHEREAS, the move of City Hall to the Showers Complex has changed the areas allocated for parking for public employees; and

WHEREAS, the charges codified for parking privileges in the various City-run facilities are stated only through 1996; and

WHEREAS, the Board of Public Works has voted to change the public employee parking areas, has numbered the various other lots at the Showers complex, and has voted to raise the fees charged for parking privileges in the City lots; and

WHEREAS, there are several changes that need to be made to this Title to reflect current administrative practices within the City;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Section 15.32.185 Public Employee Parking shall be amended to read as follows:

The streets or parts of streets described in Schedule T, attached hereto and made a part hereof, and the parking area located at the northwest portion of the parking area of the Showers Complex, 401 N. Morton Street, are designated as public employee parking zones. When appropriate signs are erected, no person shall park a vehicle upon any of the streets, parts of streets, or the said parking lot unless that person has obtained and displayed the proper public employee parking permit, and has properly displayed said permit as provided for by Chapter 15.38.

SECTION II. The first paragraph of Section 15.38.010 Eligibility shall be amended to read as follows:

Any person employed as an official of the city, or by any agency, department, or office thereof (excluding the employees of the Police Department) who owns a vehicle may apply to the city parking enforcement division for a public employee parking permit for parking privileges in areas on the streets or in Municipal Lot Number 14 that are designated as public employee parking zones by Section 15.32.185. These parking privileges, however, do not extend to the blue permit zone described below.

SECTION III. Section 15.38.030 Display of Permits shall be amended to read as follows:

No person shall park on the streets, parts of streets, or the part of Municipal Lot 14 designated as public employee parking zones without the proper public employee parking permit sticker displayed in the lower right-hand corner of the rear window of the vehicle, or in such other location designated by the city parking enforcement division.

SECTION IV. Section 15.40.010 Locations shall be amended to add the following:

Lot 12: Located at the northeast side of the Showers Complex, 401 North Morton Street;

Lot 13: Located at the south portion of the west side of the Showers Complex, 401 North Morton Street;

Lot 14: Located at the north portion of the west side of the Showers Complex, 401 North Morton Street.

SECTION V. Section 15.40.030 (a) (1) Parking permits shall be revised to delete the last two sentences in the first paragraph and to replace these sentences with the following:

The charge for such annual parking leases in the Regester Center Parking Garage and the Walnut Street Parking Garage shall be three hundred sixty five dollars (\$365.00) in 1997, three hundred seventy dollars (\$370.00) in 1998, and three hundred seventy five dollars (\$375.00) in 1999, payable in advance. The charge for such annual parking leases in Lots 2, 4 and 5 shall be three hundred fifteen dollars (\$315.00) in 1997, three hundred twenty dollars (\$320.00) in 1998, and three hundred twenty-five dollars (\$325.00) in 1999.

SECTION VI. Section 15.40.030 (a)(2) Parking permits shall be revised to delete the second sentence in the first paragraph and all of the second paragraph, and to add the following to the end of the first paragraph:

The charge for such privilege shall be three hundred ten dollars (\$310.00) in 1997, three hundred thirty dollars (\$330.00) in 1998, and three hundred fifty dollars (\$350.00) in 1999, payable in advance, or eighty-five dollars (\$85.00) in 1997, ninety dollars (\$90.00) in 1998, and ninety-five dollars (\$95.00) in 1999, per three-month period.

SECTION VII. Section 15.40.030 (b)(1) Parking permits shall be revised to delete the first sentence in the second paragraph and to replace it with the following:

The charge for such spaces shall be thirty-eight dollars (\$38.00) in 1997, thirty-nine dollars (\$39.00) in 1998, and forty dollars (\$40.00) in 1999, payable in advance.

SECTION VIII. Section 15.40.030 (b)(2) Parking permits shall be revised to delete the second sentence and to replace it with the following:

If the Class M or Class M-W permit holder has not exercised his option by the twentieth day of the month, the specific space may be leased to any individual who pays the fee of thirty-eight dollars (\$38.00) in 1997, thirty-nine dollars (\$39.00) in 1998, and forty dollars (\$40.00) in 1999.

SECTION IX. Section 15.40.030 (c) Parking permits shall be relettered as Section 15.40.030 (e) and a new Section 15.40.030 (c) shall be inserted and shall read as follows:

Leases shall be negotiated by the Board of Public Works for the lots known as Lots 12 and 13. The permits issued for Lot 12 will be a red permit and those for Lot 13 will be a white permit.

SECTION X. Section 15.40.030 (d) Parking permits shall be amended to delete the words "City Controller" and to substitute the words "Parking Enforcement Division".

SECTION XI. Section 15.40.050 (c) Violations shall be relettered as Section 15.40.050 (d) and a new Section 15.40.050 (c) shall read as follows:

No person shall park in Lot 12 without a Lot 12 permit sticker displayed in the lower right-hand corner of the rear window of the vehicle, or in other such location designated by the Parking Enforcement Division. No person shall park in Lot 13 without a Lot 13 permit sticker displayed in the lower right-hand corner of the rear window of the vehicle, or in other such location designated by the Parking Enforcement Division.

SECTION XII. Sections 15.40.050 (d) (e) and (f) Violations shall be renumbered as Sections 15.40.050 (e) (f) and (g), respectively.

SECTION XIII. Part (b) and the new part (g) of Section 15.40.050 Violations shall be amended to delete the words "City Controller" and to substitute the words "Parking Enforcement Division" wherever they appear in those parts.

SECTION XIV. This ordinance shall be in full force and effect on and after its passage by the Common Council and approval by the Mayor.

SYNOPSIS

This ordinance adds several municipally-run parking lots within the City of Bloomington, located near the new Showers Center. It deletes the public employee parking located at the old City Hall at 220 East Third Street, and adds a lot at the Showers City Hall. And, it establishes new fees for the various municipal parking lots for the years 1997 through 1999. In addition, it reassigns the responsibility for the administrative duties of the parking control functions from the Controller's office and to the Parking Enforcement Division.
