ORDINANCE 96-47

TO AMEND TITLE 15 OF THE BLOOMINGTON MUNICIPAL CODE ENTITLED "VEHICLES AND TRAFFIC" (Parking Permits and Leases)

WHEREAS, the charges codified for parking privileges in the various City-run facilities are stated only through 1996; and

WHEREAS, said charges need to be codified for 1997 to allow for lease completion and fee collection;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Section <u>15.40.030 Parking permits</u>, Part (a)(1), of the Bloomington Municipal Code shall be revised by deleting the last two sentences in the first paragraph and substituting the following sentence: "The charge for such annual parking leases in Lot 2 (7th and Walnut), Lot 4 (4th and Morton), Lot 5 (6th and Lincoln), Lot 7 (the Regester Center Parking Garage), Lot 9 (the Walnut Street Parking Garage), and Lot 11 (8th and Morton) shall be three hundred eighty dollars (\$380.00), payable in advance."

SECTION II. Section <u>15.40.030 Parking permits</u>, Part (a)(2), of the Bloomington Municipal Code shall be revised by striking the second sentence in the first paragraph and the entire second paragraph, and substituting the following sentence: "The charge for such privilege shall be three hundred and five dollars (\$305.00), payable in advance, or eighty five dollars (\$85.00) per three-month period, payable in advance."

SECTION III. Section <u>15.40.030 Parking permits</u>, Part (b), of the Bloomington Municipal Code shall be deleted and the subsequent Parts (c) and (d) be redesignated accordingly.

SECTION IV. This ordinance shall be in full force and effect on and after its passage by the Common Council and approval by the Mayor.
