

ORDINANCE 95-44

**TO AMEND TITLE 15 OF THE BLOOMINGTON CODE ENTITLED
"VEHICLES AND TRAFFIC"**

WHEREAS, the Traffic Commission have recommended certain changes be made in Title 15 of Bloomington Municipal Code entitled "Vehicles and Traffic"

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, THAT:


SECTION IV. Section 15.32.080 Schedule N shall be amended to add the following:

LIMITED PARKING ZONES



SECTION V. This ordinance shall be in full force and effect on and after its passage by the Common Council and approval by the Mayor.




