AN ORDINANCE CONCERNING THE ANNEXATION OF ADJACENT AND CONTIGUOUS TERRITORY (Hyde Park and Kensington II Area)

WHEREAS, the boundary of the City of Bloomington, Indiana, is adjacent to the real estate described herein;

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the land described below, with the following commonly known addresses: 2800-3299 East Daniel Street, 3300-3399 South Forrester Street, the odd only addresses from 3100 to 3109 Daniel Court, 3300-3399 Daniel Court, 3400-3499 East Brookstone Court, 3100-3199 South Daniel Street, 2800-3099 South Olcott Boulevard, 3600-3699 East Jordan's Way, 3700-3899 East St. Remy Drive, 3700-3899 East St. Remy Circle, 2800-2999 South King Court, 2800-2999 South Dale Court, 3300-3499 East Olcott Boulevard, 3100-3199 South Mulberry Lane, 3300-3399 East Mulberry Court, 3300-3499 East Mulberry Lane - be annexed to and declared a part of the City of Bloomington, Indiana, to-wit:

SECTION 4. Pursuant to I.C. 36-4-3-7(d) and (e) this ordinance shall take effect the second January 1 that follows its passage and adoption by the Common Council of the City of Bloomington and approval of the Mayor, and the City herein acknowledges its obligations at the time of the annexation.
