

ORDINANCE 95-76

TO AMEND CHAPTER 3.02 OF THE BLOOMINGTON MUNICIPAL CODE  
ENTITLED, "CABLE COMMUNICATIONS FRANCHISES"  
(Authorizing an Informal Process for the Renewal  
of Cable Franchises)

WHEREAS, federal statutes allow cable franchising authorities to renew franchise agreements through formal or informal procedures, singly or in combination; and

WHEREAS, the City of Bloomington wishes to incorporate the informal method of franchise renewal into its cable refranchising ordinance, to function in lieu of, or in addition to, its previously adopted formal procedures;

NOW THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. ~~Section 3.02.041 Procedures governing the renewal of existing franchises shall be amended to add the following:~~


(h) Notwithstanding the provisions of subsections (a) through (g) of this section, a cable operator may, either on its own initiative, or after consultation and/or negotiation with the City, submit to the Board a proposal for the renewal of a franchise at any time. The Board may, after affording the public adequate notice and opportunity for comment, grant or deny such proposal at any time (including after proceedings pursuant to this section have commenced). The provisions of subsections (a) through (g) of this section shall not apply to a decision to grant or deny a proposal under this subsection. The denial of a renewal pursuant to this subsection shall not affect action on a renewal proposal that is submitted in accordance with subsections (a) through (g) of this section.



## Synopsis

This amendment allows the City to consider proposals for renewal of a franchise agreement which are submitted in lieu of, or in addition to, the formal renewal process. Federal law, 47 U.S.C. § 546, permits both "formal" and "informal" renewal procedures. Under either procedure, renewal of a franchise will require public notice and comment on the proposal, and action by the Board of Public Works and Common Council.
