ORDINANCE 94-60

AN ORDINANCE CONCERNING THE ANNEXATION OF ADJACENT AND CONTIGUOUS TERRITORY (Rockport Area)

WHEREAS, the Boundary of the City of Bloomington, Indiana, is adjacent to the real estate described herein;

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION I. That the following described land, commonly known as Cherokee, Chambers, Duncan, and Guy Streets, Rockport Hills, and Autumn View, all west of the 2100-2400 block of Rockport Road, be annexed to and declared a part of the City of Bloomington, Indiana, to-wit:

A part of Section 8, Township 8 North, Range 1 West, Monroe County, Indiana, being more particularly described as follows:

BEGINNING at the center of said Section 8; thence along Annexation Ordinance Number 91-65 the following four (4) courses:

- 1). Northerly 1069 feet, more or less; thence
- 2). Easterly 690 feet, more or less; thence
- 3). Northerly 363 feet, more or less; thence
- 4). Easterly 1155 feet, more or less to the westerly right-of-way of Rogers Street and also being the westerly line of Annexation Ordinance Number 63-37; thence along said ordinance the following three (3) courses:
- 1). Southerly 360 feet, more or less; thence
- 2). Southwesterly 2250 feet, more or less; thence
- 3). Westerly 1795 feet, more or less, to the northwest corner of said ordinance on the west line of the Northeast Quarter of the Southwest Quarter of said Section 8;

thence northerly 687 feet, more or less, along said west line to the northwest corner of said quarter quarter section on the south line of the aforesaid ordinance number 91-65; thence easterly 1311 feet, more or less, along said ordinance to the POINT OF BEGINNING, containing 83 acres, more or less.

SECTION II. Be it further ordained, that the boundaries of the City of Bloomington shall be, and the same are, hereby declared to be extended so as to include all of the real estate hereinabove described as part of the City of Bloomington, Indiana.

SECTION III. Pursuant to I.C. 36-4-3-3(d), the above described territory, which is hereby annexed to and declared a part of the City of Bloomington, Indiana, shall be assigned to Bloomington Common Council District Five.

SECTION IV. Pursuant to I.C.36-4-3-7(d) and (e) this Ordinance shall take effect the second January 1 that follows its passage and adoption by the Common Council of the City of Bloomington and approval of the Mayor, and the City herein acknowledges its obligations at the time of the annexation.


