## TO APPROVE APPLICATION AND AUTHORIZE LOAN FROM THE BLOOMINGTON INDUSTRIAL INCENTIVE LOAN FUND (Bloomington Developmental Learning Center, Petitioner)

- WHEREAS, on March 5, 1986, the Common Council of the City of Bloomington established the Bloomington Industrial Incentive Loan Fund and approved and authorized Guidelines and Procedures for the use of the Industrial Incentive Loan Fund; and

- WHEREAS, the Bloomington Developmental Learning Center has filed an application for an Industrial Incentive Loan through the Bloomington Industrial Incentive Loan Fund, which application has been approved by the Redevelopment Commission of the City of Bloomington and forwarded to the Common Council for its approval;

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, THAT:

A loan not to exceed sixty-nine thousand one hundred dollars (\$69,100) from the City of Bloomington Industrial Incentive Loan Fund established in <u>Ordinance 86-4</u> to Bloomington Developmental Learning Center, is hereby approved, for a maximum term of five (5) years and subject to a 3.85% rate of interest. The Controller of the city of Bloomington is hereby authorized to release funds in the amount specified and subject to the specific terms and conditions and repayment plan approved by the City of Bloomington Redevelopment Commission in Commission <u>Resolution 93-64</u>, together with all terms and conditions contained in Common Council <u>Resolution 86-6</u> "Program Guidelines".

This Resolution shall be in full force and effect from and after passage by the Common Council of the City of Bloomington and approval by the Mayor.
