

RESOLUTION 94-31
TO EXPAND BENEFITS TO REGULAR PART-TIME EMPLOYEES

WHEREAS, part-time employees are an occupational fact-of-life for this country and community; and

WHEREAS, part-time employees of the City of Bloomington provide a valuable contribution to the operation of the City and deserve benefits that address their medical and longterm financial well being; and

WHEREAS, the City of Bloomington has led the way among Indiana cities in providing employment benefits to the City's part-time employees; and

WHEREAS, for example, regular part-time employees of the City who work at least 20 hours a week enjoy holidays, accrue sick and vacation days, are eligible for life and medical insurance, and may participate in a deferred compensation retirement program; and

WHEREAS, while permitted by statute, however, those regular part-time employees who work at least 20 hours a week are not currently eligible for the Public Employment Retirement Fund (PERF) and those who work less than 20 hours a week do not receive any of the above benefits; and

WHEREAS, in 1995 the City could give regular part-time employees who work less than 20 hours a week access to the City health benefits at full cost to the employee; and


WHEREAS, Councilmember Bonnell has proposed a program that would extend PERF benefits to regular part-time employees who work at least 20 hours a week and include those regular part-time employees who work less than 20 hours a week in our self-funded health care program at prorated premiums; and

WHEREAS, this is a matter that should be studied by the Administration and the Council in time to make recommendations for possible implementation in 1996;


NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

In 1995, the City should give regular part-time employees who work less than 20 hours a week access to the City health benefits at full cost to the employee. And, the City should explore providing PERF benefits to regular part-time employees who work at least 20 hours a week and providing health benefits at reasonably prorated rates to regular part-time employees who work less than 20 hours a week for 1996.
