ORDINANCE 93-06 TO AMEND THE TEXT OF

TITLE 20 OF THE BLOOMINGTON MUNICIPAL CODE ENTITLED, "ZONING" Re: Shifting Authority for Approving Conditional Uses from the Plan Commission to the Board of Zoning Appeals

WHEREAS, the Plan Commission has considered and recommended that the Bloomington Municipal Code be changed.

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. In <u>Section 20.07.02.00 (f)</u>, <u>Determination in which</u> <u>zone a specific use is permitted</u>, the words "Board of Zoning Appeals" shall replace the words "Plan Commission".

SECTION II. In <u>Section 20.07.08.00, Conditional Uses</u>, the words "Board of Zoning Appeals" shall replace the words "Plan Commission".

SECTION III. In <u>Section 20.07.08.02</u>, <u>Procedures for granting</u> <u>conditional permit</u>, the words "Board of Zoning Appeals" shall replace the words "Plan Commission".

SECTION IV. In <u>Section 20.10.00.00, Regulations for</u> <u>Conditional Uses, Purpose</u>, the words "Board of Zoning Appeals" shall replace the words "Plan Commission".

SECTION V. In <u>Section 20.10.01.00, Regulations for</u> <u>Conditional Uses, General Regulations and Conditions</u>, subsections 20.10.01.01 through 20.10.01.05, the words "Board of Zoning Appeals" shall replace the words "Plan Commission".

SECTION VI. In <u>Section 20.10.02.00 Schools</u>, parks, playgrounds <u>and related facilities</u>, Subsection 20.10.02.01, the words "Board of Zoning Appeals" shall replace the words "Plan Commission".

SECTION VII. In <u>Section 20.10.04.00, Religious organizations</u>, the words "Board of Zoning Appeals" shall replace the words "Plan Commission".

SECTION VIII. In <u>Section 20.10.05.00</u>, <u>Civic or community clubs</u>, the words "Board of Zoning Appeals" shall replace the words "Plan Commission".

SECTION IX. In <u>Section 20.10.06.00, Funeral services</u>, the words "Board of Zoning Appeals" shall replace the words "Plan Commission".

SECTION X. In <u>Section 20.10.07.00 Duplex in residential</u> <u>single (RS) zone</u>, the words "Board of Zoning Appeals" shall replace the words "Plan Commission".

SECTION XI. In <u>Section 20.10.08.00</u>, <u>Accessory gasoline sales</u> <u>in limited business zones</u>, the words "Board of Zoning Appeals" shall replace the words "Plan Commission".

SECTION XII. In <u>Section 20.10.09.00, Higher density residential</u> <u>development</u>, and in subsection 20.10.09.00(d), the words "Board of Zoning Appeals" shall replace the words "Plan Commission".

SECTION XIII. In <u>Section 20.15.06.00</u>, <u>Conditional uses in flood</u> <u>hazard districts</u>, the words "Board of Zoning Appeals" shall replace the words "Plan Commission".

SECTION XIV. SEVERABILITY. If any section, sentence or provision of this ordinance or the application thereof to any person or circumstances shall be declared invalid, such invalidity shall not affect any of the other parts of this ordinance which can be given effect without the invalid part, and to this end the provisions of this ordinance are declared to be severable. SECTION XV. This ordinance shall be in full force and effect form and after its passage by the Common Council and approval by the Mayor.
