

ORDINANCE 93-09

TO AMEND TITLE 15 OF THE BLOOMINGTON MUNICIPAL CODE ENTITLED "VEHICLES AND TRAFFIC" Re: South Walnut

WHEREAS, the Legal Department and the Traffic Commission have recommended certain changes be made in Title 15 of Bloomington Municipal Code entitled "Vehicles and Traffic";

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Section 15.12.010 Schedule A shall be amended to delete the following:

STOP INTERSECTIONS

Table with 2 columns: Traffic On, Shall Stop For Traffic On. Rows include College Avenue, First Street, Miller Drive, Dodds Street, College Avenue, Walnut Street.

SECTION II. Section 15.12.020 Schedule C shall be amended to add the following:

YIELD INTERSECTIONS

Table with 2 columns: Traffic On, Shall Stop For Traffic On. Rows include College Avenue, Dodds Street (northbound), Dodds Street, Walnut Street.

SECTION III. Section 15.12.030 Schedule D shall be amended to add the following:

SIGNALIZED INTERSECTIONS

Table with 4 columns: Cross Street, Cross Street, Flashing Hours and Days, Preference. Rows include College Ave, First Street, Walnut Street, Miller Drive.

SECTION IV. Section 15.16.010 Schedule E shall be amended to delete the following:

ONE-WAY STREETS

Table with 4 columns: Street, From, To, Direction of Travel. Row includes Walnut Street, Second Street, SR 45 - SR 46, North.

SECTION V. Section 15.16.010 Schedule E shall be amended to add the following:

ONE-WAY STREETS

Table with 4 columns: Street, From, To, Direction of Travel. Rows include Walnut Street, Dodds Street, 130 Ft South of Dodds St, College Avenue, SR 45 - SR 46, Walnut Street, North, East.

SECTION VI. Section 15.24.020 Schedule I shall be amended to add the following:

INCREASED OR DECREASED STATE SPEED LIMIT

<u>Street</u>	<u>From</u>	<u>To</u>	<u>Posted Speed</u>
Fee Lane	Tenth Street	Seventeenth St	25 MPH

SECTION VII. Section 15.32.080 Schedule M shall be amended to delete the following:

NO PARKING ZONES

<u>Street</u>	<u>From</u>	<u>To</u>	<u>Side of Street</u>	<u>Time of Restriction</u>
First St	Walnut St	1st Alley E. of Walnut St	South	Anytime


SECTION VIII. Section 15.32.080 Schedule N shall be amended to delete the following:

LIMITED PARKING ZONES

<u>Street</u>	<u>From</u>	<u>To</u>	<u>Side of Street</u>	<u>Limit</u>
Madison St	Dead End S of Allen St	Dodds St	West	2 HR (2)


SECTION IX. This Ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.
