

ORDINANCE 93-16

TO AMEND TITLE 15 OF THE BLOOMINGTON MUNICIPAL CODE ENTITLED
"VEHICLES AND TRAFFIC"
(Amending the Residential Neighborhood Parking Program by
Changing Its Name, Expanding Zone 1 [Elm Heights] and
Establishing Zone 2 [Eastside])

- WHEREAS, excessive commuter parking in neighborhoods surrounding the university creates a traffic safety hazard to pedestrians, bicyclists and other motorists; and
- WHEREAS, the City desires to protect these neighborhoods from excessive noise, traffic, and safety hazards caused by commuter traffic; and
- WHEREAS, restrictions on parking are called for in the Bloomington Growth Policies Plan to preserve neighborhood quality of life and the residential character of neighborhoods; and
- WHEREAS, the City in 1992 adopted Ordinance 92-06 establishing a Residential Neighborhood Permit Parking program to relieve the pressure of commuter traffic in neighborhoods; and
- WHEREAS, the City has worked with Indiana University to take positive steps toward providing alternative means of transportation for commuters; and
- WHEREAS, the City recognizes the necessity of having a comprehensive parking policy which includes all affected neighborhoods;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Pursuant to Section VII of Ordinance 92-06, this ordinance affirms the continuation of the University Proximate Residential Neighborhood Permit Parking program beyond August 15, 1993.

SECTION II. Section 15.37.020 Applicability shall be deleted and replaced with the following:

Section 15.37.020 Applicability The following Zones are designated as University Proximate Residential Neighborhood Permit Parking Zones:

Elm Heights University Proximate Residential Neighborhood Permit Parking Zone (Zone 1) shall apply to the following streets:

Parking Permits and Visitor Permits valid for one zone shall not be valid for another zone.

SECTION III. Section 15.37.170 Fraternities and Sororities, is created and reads as follows:


Section 15.37.170 Fraternities and Sororities The Board of Public Works may provide up to one hundred and fifty (150) Zone 1 Parking Permits annually to residents of fraternity and sorority houses on Third Street.

SECTION IV. This Ordinance shall be effective on August 15, 1993.


SECTION V. In furtherance of the comprehensive approach toward university proximate, residential neighborhood parking, the City shall formulate and implement appropriate zones for the remaining affected neighborhoods by August 15, 1994.

SECTION VI. Severability. If any section, sentence, or provision of this ordinance, or the application thereof to any person or circumstance shall be declared invalid, such invalidity shall not affect any of the other sections, sentences, provisions, or applications of this ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared to be severable.
