## ORDINANCE 93-17

## TO AMEND TITLE 15 OF THE BLOOMINGTON MUNICIPAL CODE ENTITLED "VEHICLES AND TRAFFIC"

(Establishing Zone 3 [Green Acres] of the University Proximate Residential Neighborhood Permit Parking Program)

- WHEREAS, excessive commuter parking in neighborhoods surrounding the university creates a traffic safety hazard to pedestrians, bicyclists and other motorists; and
- WHEREAS, the City desires to protect these neighborhoods from excessive noise, traffic, and safety hazards caused by commuter traffic; and
- WHEREAS, restrictions on parking are called for in the Bloomington Growth Policies Plan to preserve neighborhood quality of life and the residential character of neighborhoods; and
- WHEREAS, the City in 1992 adopted Ordinance 92-06 establishing a Residential Neighborhood Permit Parking program to relieve the pressure of commuter traffic in neighborhoods; and
- WHEREAS, the City has worked with Indiana University to take positive steps toward providing alternative means of transportation for commuters;
- WHEREAS, the City recognizes the necessity of having a comprehensive parking policy which includes all affected neighborhoods;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. <u>Section 15.37.020 Applicability</u> shall be amended to add the following after the Zone 2 chart:

Green Acres University Proximate Residential Neighborhood Permit Parking Zone (Zone 3) shall apply to the following streets:

Parking Permits and Visitor Permits valid for one zone shall not be valid for another zone.

SECTION II. This Ordinance shall be effective on August 15, 1993.

SECTION III. Severability. If any section, sentence, or provision of this ordinance, or the application thereof to any person or circumstance shall be declared invalid, such invalidity shall not affect any of the other sections, sentences, provisions, or applications of this ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared to be severable.
