ORDINANCE 93-21

TO AMEND TITLE 15 OF THE BLOOMINGTON CODE ENTITLED "VEHICLES AND TRAFFIC"

WHEREAS, the Traffic Commission have recommended certain changes be made in Title 15 of Bloomington Municipal Code entitled "Vehicles and Traffic";

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, THAT:

SECTION I. Section 15.12.010 Schedule A shall be amended to delete the following:

SECTION III. Section 15.32.080 Schedule M shall be amended to add the following:

NO PARKING ZONES
