

ORDINANCE 93-25

TO AMEND TITLE 15 OF THE BLOOMINGTON CODE ENTITLED "VEHICLES AND TRAFFIC"

WHEREAS, the Traffic Commission have recommended certain changes be made in Title 15 of Bloomington Municipal Code entitled "Vehicles and Traffic"

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Section 15.32.080 Schedule M shall be amended to delete the following:

NO PARKING ZONES

<u>Street</u>	<u>From</u>	<u>To</u>	<u>Side of Street</u>	<u>Time of Restriction</u>
Hawthorne	Southdowns	Maxwell Ln	East	Anytime

SECTION II. Section 15.32.080 Schedule N shall be amended to delete the following:

LIMITED PARKING ZONES

<u>Street</u>	<u>From</u>	<u>To</u>	<u>Side of Street</u>	<u>Limit</u>
Rose Ave	Hunter Ave	Third St	West	2 HR (6)

SECTION III. Section 15.37.080 Schedule N shall be amended to add the following:

LIMITED PARKING ZONES

<u>Street</u>	<u>From</u>	<u>To</u>	<u>Side of Street</u>	<u>Limit</u>
Washington St	30' S. of 2nd St	50' S. of 2nd St	West	30 min (3)

SECTION IV. Section 15.32.150 Schedule S shall be amended to add the following:

HANDICAPPED PARKING

Indiana University Office of Publications (638 North Rogers)
-- One space located on Rogers Street

SECTION V. Section 15.32.170 Municipal Parking Lot 5 Parking During Market Season shall be repealed and reenacted to read as follows:

No person other than a registered market vendor shall park a vehicle in a parking space in Municipal Parking Lot 5, located at Sixth and Lincoln Streets, during the hours of 4:00 a.m. through 1:00 p.m. on Saturdays during the market season as defined by the Human Resources Department and as designated by temporary signs. Dates for the season shall be publicized throughout the community and posted in Municipal Parking Lot 5 prior to enforcement of this provision. Towing may occur for as long as the Farmers' Market is held in Lot 5.

SECTION VI. This ordinance shall be in full force and effect on and after its passage by the Common Council and approval by the Mayor.
