

ORDINANCE 93-55

TO AMEND TITLE 9 OF THE BLOOMINGTON  
MUNICIPAL CODE, ENTITLED "WATER"  
(Indiana Utility Regulatory Commission Adjustment of  
Rates Established in Ordinance 93-40)

- WHEREAS, City of Bloomington Utilities has had no adjustment in water rates since March 1, 1989; and
- WHEREAS, City of Bloomington Utilities has been granted authorization from the Indiana Utility Regulatory Commission to adjust water rates in order to permit rates to reflect inflation and increased costs of supplying water and services to customers; and
- WHEREAS, approval of an order by the IURC requires a reflection of the new rates in the Bloomington Municipal Code; and
- WHEREAS, the State Legislature has passed a law permitting public utilities or municipally owned water utilities to assess rate payers for the fire protection benefits the rate payers receive from the utility, provided the municipality adopts the provisions of Ind. Code 8-1-2-103;

BE IT HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Section 9.08.010 Monthly rates generally of Chapter 9.08 of title 9 of the Bloomington Municipal Code, shall be amended to read as follows:

9.08.010 Monthly rates generally. The following rates and charges are established for the use of and service rendered by the water utility of the city. Each customer will pay a monthly charge according to the following schedules:

Monthly usage charge applicable to Residential, Commercial, Industrial, Interdepartmental, and Indiana University Revenue Meter Classes.

| <u>Monthly Usage</u> | <u>Rate per 1,000 Gallons</u> |
|----------------------|-------------------------------|
| First 20,000 Gallons | \$1.42                        |
| Next 280,000 Gallons | 1.14                          |
| Over 300,000 Gallons | 1.00                          |

Monthly usage charge applicable to Indiana University Master Meters in Addition to Monthly Service Charge.

SECTION II. Section 9.08.020 Contract Sales for resale of Chapter 9.08 of title 9 of the Bloomington Municipal Code, shall be amended to read as follows:

9.08.020 Contract Sales for Resale. The rates for contract sales for resale shall be \$ 0.894 per one thousand gallons.

SECTION III. Section 9.08.030 Municipal hydrant rates of Chapter 9.08 of title 9 of the Bloomington Municipal Code, shall be amended to read as follows:

9.08.030 Municipal Hydrant Rates. The City of Bloomington adopts the provisions of Ind. Code §8-1-2-103(d). The charges for production, storage, transmission, sale and delivery, or furnishing of water for public fire protection purposes shall be added to the basic rates of all customers of the utility. The effective date for addition of these charges in the basic rate shall be December 1, 1993.

After December 1, 1993 the construction cost of any fire hydrant installed at the request of the municipality shall be paid for by or on behalf of the municipality.

SECTION IV. Section 9.08.040 Private fire connection of Chapter 9.08 of Title 9 of the Bloomington Municipal Code, shall be amended to read as follows:


SECTION V. Customer billing shall be computed with these rates for the first full billing cycle following final approval by the Indiana Utility Regulatory Commission.

SECTION VI. This ordinance shall be in full force and effect from and after its passage by the Council, approval by the Mayor, and promulgation according to law.

SECTION VII. Severability. If any section, sentence, or provision of this ordinance or the application thereof to any person or circumstance shall be declared invalid, such invalidity

shall not affect any of the other parts of this ordinance which can be given effect without the invalid part, and to this end the provisions of this ordinance are declared to be severable.



#### SYNOPSIS

This ordinance amends Title 9 of the BMC, entitled "Water", to reflect rate adjustments and to adopt the provisions of the new Indiana law that allows water utilities to pass the costs of public fire protection on to the rate payers. This ordinance is a technical correction of rates approved in Ordinance 93-40 to reflect rates as approved by the Indiana Utility Regulatory Commission in Cause # 39699.
