RESOLUTION 93-1 IN SUPPORT OF FUNDING FOR A NEW FACILITY AT THE IVY TECH BLOOMINGTON CAMPUS

- WHEREAS, the current facility for the Indiana Vocational Technical College (Ivy Tech) in Bloomington consists of four small buildings originally designed for commercial use; and
- WHEREAS, an advisory committee of community leaders that was formed in 1991 studied the space needs and location for a new facility and determined an overwhelming need for expansion; and
- WHEREAS, the site of the existing facility is on SR 37 and 46 and easily accessible from Bloomington, Ellettsville, and the surrounding communities; and
- WHEREAS, the mission of this facility is to develop people, promote education, forge partnerships with business and industry, stimulate employment and foster opportunity; and
- WHEREAS, in pursuit of this mission the facility provides practical training to individuals who are seeking to improve their employment opportunities or to enhance their skills at their current place of employment; and
- WHEREAS, from 1985 to 1992 the enrollment at this facility has gone from eight hundred and ten (810) to well over thirteen hundred (1300); and
- WHEREAS, in order to meet the increased demands of enrollment, classes are held six days and five evenings a week at site and sometimes at a local high school; and
- WHEREAS, ninety-five percent (95%) of their recent Associate

 Degree graduates obtained work in a related field; and
- WHEREAS, the City of Bloomington supports this vital and successful element in the state's higher education curriculum, and recognizes its contribution to our community's economic development;

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

The City of Bloomington urges the State Legislature to approve and fund the construction of a new, approximately one hundred and ten thousand (110,00) square foot, fifteen million nine hundred and sixty-seven thousand dollar (\$15,967,000) facility for the Ivy Tech Bloomington campus in 1993.
