ORDINANCE 92-07

TO AMEND TITLE 15 OF THE BLOOMINGTON CODE ENTITLED
"VEHICLES AND TRAFFIC"

WHEREAS, the Traffic Commission has recommended certain changes be made in Title 15 of the Bloomington Municipal Code entitled "Vehicles and Traffic"

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:


