ORDINANCE 92 - 16

To Amend the Bloomington Zoning Maps from RS to RL, Grant PUD Designation, and Outline Plan Approval Re: Miller Drive Barclay Gardens Addition Lots 60, 61, 63, 64, 65, 66, & 67 (David Shields, Kevin Spicer, and Black-Jack Rentals)

- WHEREAS, the Common Council passed a Zoning ordinance amendment and adopted new incorporated zoning maps on June 7, 1978 which are now incorporated in Title 20 of the Bloomington Municipal Code; and
- WHEREAS, the Plan Commission has considered this case, RL/PUD-15-92, and recommended that the petitioners, David Shields, Kevin Spicer, and Black-Jack Rentals, be denied an amendment to the Bloomington zoning maps, PUD designation, and outline plan approval and request that the Common Council consider their petition for rezoning of certain property.

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Through the authority of IC 36-7-4 that the zoning be changed from RS to RL for property located on the north side of Miller Drive east of its intersection with Henderson Street. The property is further described as follows:

Barclay Gardens Addition Lots 60, 61, 63, 64, 65, 66, & 67.

SECTION II. Through the authority of IC 36-7-4 and pursuant to Chapter 20.13 of the Bloomington Municipal Code, that an outline plan be approved and that the property described above be designated a planned unit development.

SECTION III. The Outline Plan shall be attached hereto and made a part thereof.

SECTION IV. This ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.
