

ORDINANCE 92-19

TO VACATE TWO PUBLIC PARCELS
Re: TWO PLATTED ALLEYS AT 700 WEST HOWE STREET
(FIRST CHURCH OF THE NAZARENE, PETITIONER)

WHEREAS, I.C. 36-7-3-12 authorizes the Common Council to vacate public ways and places upon petition of persons who own or are interested in lots contiguous to those public ways and places; and

WHEREAS, the petitioner, First Church of the Nazarene, has filed a petition to vacate a parcel of City property more particularly described below;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Through the authority of I.C. 36-7-3-12, a portion of City owned property shall be vacated. The properties are more particularly described as follows:

Two platted alleys at 700 W. Howe Street:

Alley #1: An 11 foot alley running north and south along the entire westside of Lot 27 of East and Marshall Addition to the City Bloomington as shown on the plat recorded in Plat Book 1, page 36 in the Office of the Recorder of Monroe County, Indiana, more particularly described as follows:

Beginning at the Southwest corner of Lot 27 in East and Marshall Addition thence North 133.42 feet thence East 11 feet thence South 133.42 feet thence West 11 feet and to the point of the beginning.

Alley #2: A 10 foot alley running north and south between Lots 25 and 26 of East and Marshall Addition to the City of Bloomington as shown on the plat recorded of Monroe County, Indiana, more particularly described as follows:

Beginning at Southwest corner of Lot 25 in East and Marshall Addition thence West 10 feet thence North 133.42 feet thence East 10 feet thence East 133.42 feet and to the point of beginning.

SECTION II. This Ordinance shall be in full force and effect from and after its passage by the Common Council of the City of Bloomington and approval of the Mayor.
