

ORDINANCE 92-26

TO AMEND TITLE 15 OF THE BLOOMINGTON CODE ENTITLED "VEHICLES AND TRAFFIC"

WHEREAS, the Traffic Commission has recommended certain changes be made in Title 15 of the Bloomington Municipal Code entitled "Vehicles and Traffic"

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Section 15.12.010 Stop Intersections shall be amended to delete the following:

SECTION VIII. Section 15.32.150 Handicapped Parking shall be amended to add the following:

Justice Building -- The first space south of Eighth Street on the west side of College Avenue.

\*\* All handicapped parking spaces within the 2 hour limit parking zones shall be limited to 4 hours.

SECTION IX. Section 15.32.185 Public Employee Parking shall be repealed and re-enacted to read as follows:

15.32.185 Public employee parking The streets or parts of streets described in Schedule T, attached hereto and made part hereof, and the parking area at the 200 block of East Third Street, without parking meters (not a part of City Municipal Lot 6 as defined in Section 15.40.010 nor the handicapped parking space located there, as stated in Section 15.32.150 Schedule S), are designated as public employee parking zones. When appropriate signs are erected, no person shall park a vehicle upon any of the streets, parts of streets, or the said parking lot unless that person has obtained and displayed the proper public employee parking permit, and has properly displayed said permit as provided for by Chapter 15.38.

SECTION X. Section 15.38.020 Application and Issuance of Permit shall be repealed and re-enacted to read as follows:

The application form shall contain the name of the employee, governmental entity and department, and office telephone number of the employee applying for the permit, and shall be submitted to the city parking enforcement division, which shall issue a permit.

SECTION XI. Section 15.38.030 Display of Permits shall be repealed and re-enacted as follows:

No person shall park on the streets, parts of streets, or the part of the Municipal Lot Number 6 designated as public employee parking zones without the proper public employee parking permit sticker displayed in the lower right-hand corner of the rear window of the vehicle, or in such other location designated by the city parking enforcement division.

SECTION XII. Section 15.60.050 Pedestrians shall be amended to add the following:

100 Block of South Jordan Avenue @ IUMAC.

200 Block of North Jordan Avenue @ Black Studies Entrance.

600 Block of South Rogers Street between First Street and Second Street.

600 Block of West First Street between South Rogers Street and Bloomington Hospital's Emergency Entrance.

900 Block of North Maple Street between Thirteenth Street and Fifteenth Street.

1000 Block of Winslow Road between Abbey Lane and Allendale Drive.


2200 Block of South High Street @ Childs Elementary School.

SECTION XIII. This ordinance shall be in full force and effect on and after its passage by the Common Council and approval by the Mayor.
