#### ORDINANCE 92-28

### TO VACATE A PUBLIC PARCEL RE: RIGHT-OF-WAY LOCATED AT 318 N. ROGERS STREET (KELLER HEATING AND COOLING, PETITIONER)

- WHEREAS, I.C. 36-7-3-12 authorizes the Common Council to vacate public ways and places upon petition of persons who own or are interested in lots contiguous to those public ways and places; and
- WHEREAS, the petitioner, Keller Heating and Cooling, has filed a petition to vacate a parcel of city owned right-of-way to the west of his property more particularly described below; and
- WHEREAS, in exchange for vacating this parcel, the petitioner has agreed to dedicate a like parcel of right-of-way on the east side of his property more particularly described below; and
- WHEREAS, on May 6, 1992, the Board of Public Works recommended approval of this exchange.

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Through the authority of I.C. 36-7-3-12 and upon conditions set out in Section II of this ordinance, a portion of City owned property shall be vacated. The property is located at 318 N. Rogers and is more particularly described as follows:

Part of North Rogers Street in the Original Plat of the City of Bloomington, Indiana as recorded in Plat Cabinet "B", Envelope 1, Office of the Recorder of Monroe County, Indiana, more particularly described as follows:

Beginning at the Northwest corner of Lot 292 of said Original Plat; thence South 00 degrees 06 minutes 58 seconds West along the West lines of Lots 292 and 291 of said Original Plat 132.00 feet to a rebar set at the Southwest corner of said Lot 291; thence South 89 degrees 51 minutes 24 seconds West 5.12 feet; thence North 00 degrees 06 minutes 58 seconds East 132.00 feet; thence North 89 degrees 51 minutes 24 seconds East 5.12 feet to the point of beginning, containing 0.016 acres, more or less.

SECTION II. This vacation of right-of-way is contingent upon the petitioner dedicating to the City of Bloomington a parcel of right-ofway located behind 318 N. Rogers Street and more particularly described as follows:

Part of Lots 291 and 292 of the Original Plat of the City of Bloomington, Indiana as recorded in Plat Cabinet "B", Envelope 1, Office of the Recorder of Monroe County, Indiana, more particularly described as follows:

Beginning at the Northeast corner of said Lot 292; thence South 00 degrees 06 minutes 58 seconds West along the East side of said lots 292 and 291 for 132.00 feet to the Southeast corner of said Lot 291; thence South 89 degrees 51 minutes 24 seconds West along the South line of said Lot 291 for 5.12 feet; thence North 00 degrees 06 minutes 58 seconds East 132.00 feet to the North line of said Lot 292; thence North 89 degrees 51 minutes 24 seconds East along said North line 5.21 feet to the point of the beginning, containing 0.016 acres, more or less.

SECTION III. This Ordinance shall be in full force and effect from and after its passage by the Common Council of the City of Bloomington and approval of the Mayor.
