

ORDINANCE 92-60
AN ORDINANCE CONCERNING THE ANNEXATION OF
ADJACENT AND CONTIGUOUS TERRITORY
(Ryan's Family Steak House)

WHEREAS, the Boundary of the City of Bloomington, Indiana, is adjacent to the real estate described herein.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described land, commonly known as Ryan's Family Steak House, located at 4400 E. Third Street be, and the same is, hereby annexed to and declared a part of the City of Bloomington, Indiana, to-wit:

Part of the Northwest quarter of Section 1, Township 8 North, Range 1 West, Monroe County, Indiana, more particularly described as follows:


Beginning at the Northeast corner of the Northwest quarter of the Northwest quarter of said Section 1; thence NORTH 89 degrees 36 minutes 31 seconds WEST 238.93 feet concurrent with the north line of Section 1; thence leaving said line SOUTH 02 degrees 10 minutes 19 seconds EAST 48.79 feet to a point on the south right-of-way line of Indiana State Road 46, said point being the point of beginning; thence SOUTH 02 degrees 10 minutes 19 seconds EAST 196.31 feet; thence NORTH 89 degrees 35 minutes 48 seconds EAST 858.72 feet; thence NORTH 00 degrees 52 minutes 22 seconds WEST 196.34 feet to the south right-of-way line of Indiana State Road 46; thence NORTH 89 degrees 36 minutes 31 seconds WEST 863.16 feet concurrent with said right-of-way to the POINT OF BEGINNING, containing 3.88 acres more or less.

SECTION 2. Be it further ordained, that the boundaries of the City of Bloomington shall be, and the same are, hereby declared to be extended so as to include all of the real estate hereinabove described as part of the City of Bloomington, Indiana.


SECTION 3. Pursuant to I.C. 36-4-3-3(d), the above described territory, which is hereby annexed to and declared a part of the City of Bloomington, Indiana, shall be assigned to Bloomington Common Council District III.

SECTION 4. Pursuant to I.C.36-4-3-7(d) this Ordinance shall take effect the second January 1 that follows its passage and adoption by the Common Council of the City of Bloomington and approval of the Mayor.
