ORDINANCE 92-63

TO ESTABLISH COUNCILMANIC DISTRICTS FOR THE CITY OF BLOOMINGTON

WHEREAS, in 1992 the Common Council is required by I.C. 36-4-6-3 to divide the City into six (6) councilmanic districts which do not cross precinct lines and which are contiguous, reasonably compact, and contain, as nearly as possible, equal population.

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. That the City of Bloomington is hereby divided into six (6) councilmanic districts which shall be known as the First District, Second District, Third District, Fourth District, Fifth District, and Sixth District, which districts are hereby established as follows:

FIRST DISTRICT. The First Councilmanic District shall consist of the following designated precincts as they are established by the Monroe County Ordinance 87-27, as adopted on January 29, 1988, the legal descriptions of which are attached hereto and made a part hereof as "Exhibit A."

- (a) Bloomington Township Precincts 2,3,16,17, 23
- (b) Perry Township Precincts 1
- (c) Van Buren Township Precincts 2 and 7
- (d) All that part of the City lying in Van Buren and Richland Townships

SECOND DISTRICT. The Second Councilmanic District shall consist of the following designated precincts as they are established by the Monroe County Ordinance 89-27, as adopted on January 29, 1988, the legal descriptions of which are attached hereto and made a part hereof as "Exhibit A."

Bloomington Township Precincts 4, 5, 13, 24, 25, 26, 27

THIRD DISTRICT. The Third Councilmanic District shall consist of the following designated precincts as they are established by the Monroe County Ordinance 89-27, as adopted on January 29, 1988, the legal description of which are attached hereto and made a part of thereof as "Exhibit A."

- (a) Bloomington Township Precincts 6, 11, 14, 19, 28,
- (b) Perry Township Precinct 11

SECTION II. The district boundaries established in this ordinance supercede those established in all previous ordinances.

SECTION III. That this ordinance shall be in full force and effect form and after its passage in accordance with law.
