ORDINANCE 91-1

TO AMEND TITLE 15 OF THE BLOOMINGTON CODE ENTITLED
"VEHICLES AND TRAFFIC"

WHEREAS, the Legal Department and the Traffic Commission have recommended certain changes be made in Title 15 of Bloomington Municipal Code entitled "Vehicles and Traffic"

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Section 15.32.080 Schedule M shall be amended to add the following:

NO PARKING ZONES

SECTION II. Section 15.32.090 Schedule N shall be amended to delete the following:




