ORDINANCE 91-4

TO AMEND TITLE 15 OF THE BLOOMINGTON MUNICIPAL CODE ENTITLED "VEHICLES AND TRAFFIC"

WHEREAS, the fees for use of the various municipal parking facilities have remained unchanged since 1987; and

WHEREAS, the cost to operate such facilities has increased since that time;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Section 15.40.020 Applicable times and charges, subsection (a) shall be amended to read "fifteen cents per thirty-minute period" in lieu of "ten cents per thirty-minute period" and "twenty-five cents per sixty minutes" in lieu of "twenty cents" where such appears in the subsection for the Walnut Street Parking Garage; subsection (a) shall be amended to read "The charge for the use of municipal parking Lot 1 shall be twenty-five cents per thirty-minute period and fifty cents per sixty minutes," in lieu of "The charge for the use of municipal parking Lots 1 and 3 shall be ten cents per thirty-minute period or part thereof, and twenty cents per sixty minutes" where such appears in the subsection; also, subsection (a) is amended to read "ten cents per twenty-four minute period" in lieu of "five cents per thirty-minute period or part thereof" and "twenty-five cents per sixty minutes" in lieu of "ten cents per sixty minutes" where such appears in the subsection.

SECTION II. Section 15.64.010 Violations and penalties, subsection (d)(1) shall be amended to read "six dollars" in lieu of "five dollars"; "twelve dollars" in lieu of "ten dollars"; and "eighteen dollars" in lieu of "fifteen dollars" where such appears in the subsection.

SECTION III. Severability. If any section, sentence, or provision of this ordinance, or the application thereof to any person or circumstances shall be declared invalid, such invalidity shall not affect any of the other sections, sentences, provisions, or applications of this ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared to be severable.

SECTION IV. This Ordinance shall be in full force and effect from and after its passage by the Common Council of the City of Bloomington, Monroe County, Indiana, upon this _____ day of ______, 1991.
