#### SYNOPSIS

This ordinance amends the 1991 Salary Ordinance of appointed officers and employees of the City to upgrade the position of Human Resources Director. This upgrade is requested due to the increased job responsibilities resulting from the addition of the Job Training Partnership Act (JTPA) Program and supervision of said program's administrative staff. The JTPA program will come under the auspices of the City of Bloomington effective July 1, 1991. This ordinance also brings the position of JTPA Director and JTPA Deputy Director/Finance under the City's pay classification plan and incorporates them into the salary ordinance.
