ORDINANCE 91-67

AN ORDINANCE TO AMEND TITLE 15 OF THE BLOOMINGTON MUNICIPAL CODE AS REGARDS TRUCK ROUTES

WHEREAS, a truck route study has been performed by a professional consulting firm, funded partially by federal highway funds, and this study has resulted in recommended changes to the existing truck route ordinance; and

WHEREAS, the Bloomington Traffic Commission has recommended changes in Title 15 regarding truck routes; and

WHEREAS, the Bloomington Common Council is authorized by statute to make rules governing the parking of vehicles and vehicle traffic on public ways in the municipality;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Bloomington Municipal Code Chapter 15.28.010, Applicability, shall be amended to add "and/or has more than six wheels" after "...exceeds five tons".

SECTION II. Bloomington Municipal Code Chapter 15.28.020, Truck Routes, Schedule K, shall be amended to read as follows:

SECTION III. Bloomington Municipal Code Chapter 15.04.140, Truck Routes, shall be amended to add the following:

- (1) Through Routes. Those truck routes intended for use by trucks which do not have destination points inside the perimeter of the community.
- (2) Destination Routes. Those truck routes intended for use by trucks which do have destination points inside the perimeter of the community.
- (3) Emergency Routes. Those truck routes intended for use by trucks only when necessitated by closure of the associated through or associated destination route.

SECTION IV. Bloomington Municipal Code Chapter 15.28.020, Restrictions, shall be amended to add the following:

- (c) Trucks subject to this chapter are also subject to the requirements and responsibilities of Title 9 (Motor Vehicles) of the Indiana Code.

SECTION V. Bloomington Municipal Code Chapter 15.64.010(b) Class B Traffic Violations (Miscellaneous) shall be amended to delete the following:

Chapter 15.28 Truck Route Violations

SECTION VI. Bloomington Municipal Code Chapter 15.064.010(c), Class C Traffic Violations (Potentially dangerous violations) shall be amended to add the following:

Chapter 15.28.020 and 15.28.030 Failure to follow established Truck Route.

SECTION VIII. Severability. If any section of this Ordinance or any part of any section shall be declared invalid or unconstitutional, such declaration shall not affect the validity or constitutionality of the remaining portions.

SECTION VIII. This Ordinance shall be in full force and effect from and after its passage by the Common Council of the City of Bloomington, Monroe County, Indiana, and approval by the Mayor.
