ORDINANCE 90-15

TO VACATE A PUBLIC PARCEL  
RE: ALLEY BEHIND 1412 WEST FIFTH STREET  
(QUALITY HEATING AND AIR CONDITIONING, INC., PETITIONER)

WHEREAS, I.C. 36-7-3-12 authorizes the Common Council to vacate public ways and places upon petition of persons who own or are interested in lots contiguous to those public ways and places; and

WHEREAS, the petitioner, Quality Heating and Air Conditioning, Inc., has filed a petition to vacate a parcel of City property more particularly described below;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Through the authority of I.C. 36-7-3-12, a portion of City owned property shall be vacated. The property is more particularly described as follows:

A part of Waterman's Addition to the City of Bloomington, Indiana as recorded in Plat Book 2, page 60 Office of the Recorder of Monroe County, Indiana, more particularly described as follows:

Beginning at a P. K. set at the Southwest corner of Lot 21 of said addition; thence North 00 00'00" East along the East line of said lot 141.00 feet to a rebar set at the Northeast corner of said lot; thence North 90 00'00" East 12.00 feet to a rebar set at the Northwest corner of Lot 20 of said addition; thence South 00 00'00" East along the West line of said lot 141.00 feet to a P. K. nail set at the Southwest corner of said lot; thence North 90 00'00" West along the North line of West Fifth Street 12.00 feet to the Point of Beginning, containing 0.039 acres, more or less.

SECTION II. This Ordinance shall be in full force and effect from and after its passage by the Common Council of the City of Bloomington and approval of the Mayor.

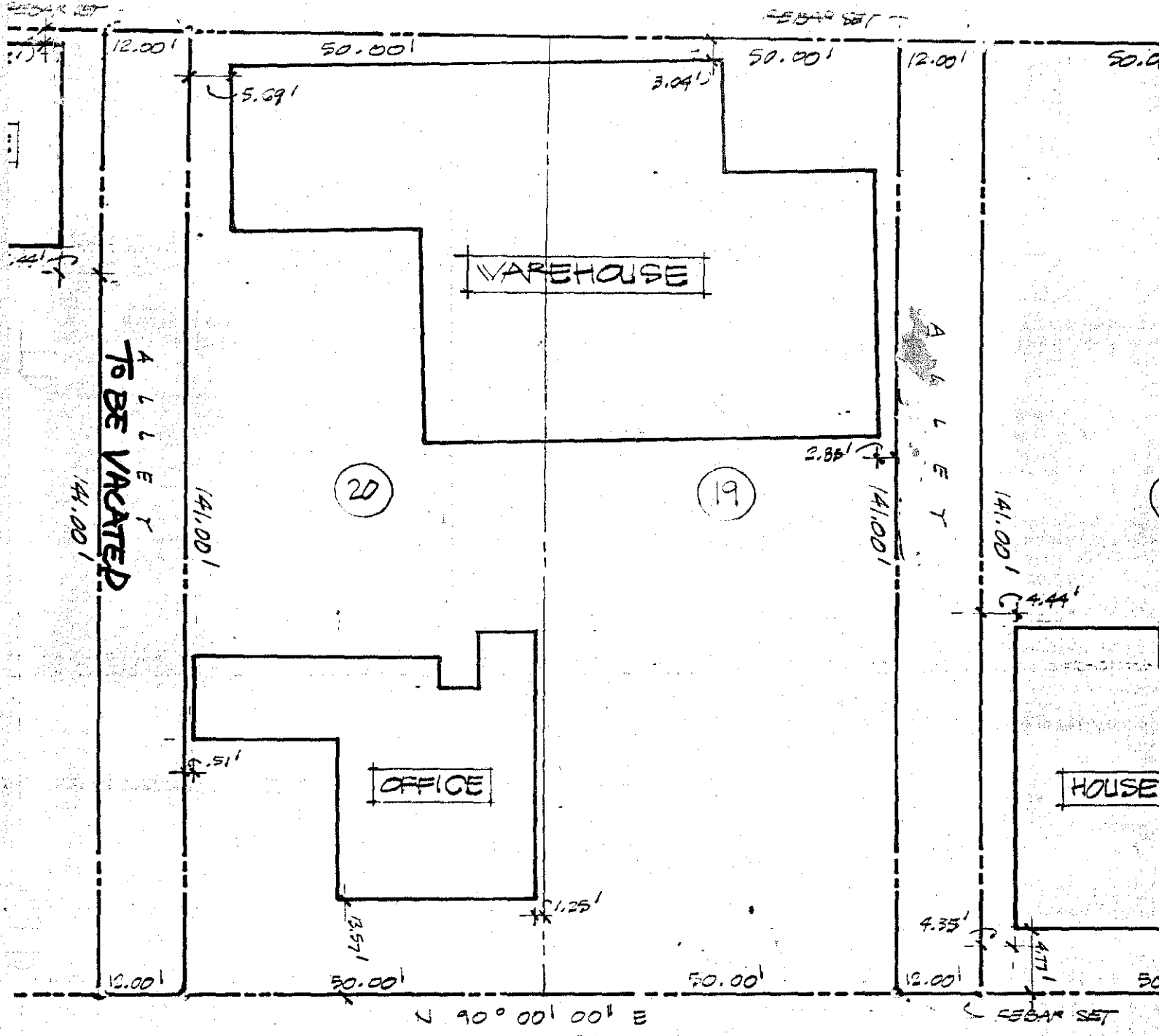
