#### ORDINANCE 90-15

TO VACATE A PUBLIC PARCEL
RE: ALLEY BEHIND 1412 WEST FIFTH STREET
(QUALITY HEATING AND AIR CONDITIONING, INC., PETITIONER)

WHEREAS, I.C. 36-7-3-12 authorizes the Common Council to vacate public ways and places upon petition of persons who own or are interested in lots contiguous to those public ways and places; and

WHEREAS, the petitioner, Quality Heating and Air Conditioning, Inc., has filed a petition to vacate a parcel of City property more particularly described below;


