## ORDINANCE 90-20

TO AMEND TITLE 2 (ADMINISTRATION AND PERSONNEL) AND TITLE 15 (VEHICLES AND TRAFFIC)
OF THE BLOOMINGTON MUNICIPAL CODE

WHEREAS, the Legal Department has recommended that certain changes be made in Title 2 (administration and personnel) and Title 15 (vehicles and traffic) of the Bloomington Municipal Code;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Section 2.20.030 Terms shall be amended to read as follows:

Appointments to the board shall be made with staggered terms. Initial appointments shall be made as follows: one term shall expire on December 31, 1986; one term shall expire on December 31, 1988; and one term shall expire on December 31, 1989. Thereafter all appointments shall be made for a term of four years and each term shall expire on December 31 of the fourth year.

SECTION II. <u>Section 2.20.120 Department of Parks and Recreation - Establishment</u> shall be amended to delete the word "not".

SECTION III. <u>Section 15.32.090 Limited Parking Zones</u> shall be amended to delete the following:

Schedule N

Dunn Street Fourth Street Sixth Street East 30 Min. (2)

SECTION IV. Section 15.32.090 Limited Parking Zones shall be amended to add the following:

Schedule N

Side of Street From To Street Limit

Dunn Street 70' north of Sixth Street East 30 Min. (2) Fourth Street

SECTION V. Section 15.60.080(a)(12) Services and Fees shall be amended so that the words "one dollar" are deleted and replaced with the words "two dollars (\$2.00)".

SECTION VI. <u>Section 2.15.000 Establishment</u> shall be amended to delete the words, "Plan Commission,".

SECTION VII. Section 2.15.020 Qualifications shall be amended to read I.C. 36-7-4-214 in lieu of I.C. 36-74-214 whenever such appears in the section.

SECTION VIII. Section 21.04.140(e) Development plans shall be repealed and re-enacted to read as follows:

Any person feeling himself aggrieved at any action of the Commission upon any proposed development plan may proceed in any court of competent jurisdiction.

Nothing in this subsection shall be construed to allow any use not otherwise permitted in the district regulations for the zoning district in which a development site is located as provided in the zoning title of the city of Bloomington.

SECTION IX. Severability. If any section, sentence, or provision of this ordinance, or the application thereof to any person or circumstances shall be declared invalid, such invalidity shall not affect any of the other sections, sentences, provisions, or applications of this ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared to be severable.

SECTION X. This Ordinance shall be in full force and effect from and after its passage by the Common Council of the City of Bloomington, approval of the Mayor and promulgation according to law.
