

ORDINANCE 89-8

To Amend Title 9 of the
Bloomington Municipal Code, Entitled "Water"

BE IT HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Section 9.08.010 Monthly rates generally of Chapter 9.08 of title 9 of the Bloomington Municipal Code, shall be amended to read as follows:

9.08.010 Monthly rates generally. The following rates and charges are established for the use of and service rendered by the water utility of the city. Each customer will pay a monthly charge according to the following schedules:

Monthly usage charge applicable to Residential, Commercial, Industrial, Interdepartmental, and Indiana University Revenue Meter Classes.

9.08.020 Contract Sales for Resale. The rates for contract sales for resale shall be \$ 0.838 per one thousand gallons.

SECTION III. Section 9.08.030 Municipal hydrant rates of Chapter 9.08 of title 9 of the Bloomington Municipal Code, shall be amended to read as follows:

9.08.030 Municipal Hydrant Rates. Annual hydrant rate, inside corporate limits shall be \$199.31/each for hydrants not privately owned or owned by Indiana University.

SECTION IV. Section 9.08.040 Private fire connections of Chapter 9.08 of title 9 of the Bloomington Municipal Code, shall be amended to read as follows:


