

ORDINANCE 89-13

TO AMEND TITLE 15 OF THE BLOOMINGTON MUNICIPAL CODE ENTITLED "VEHICLES AND TRAFFIC"

WHEREAS, the Traffic Commission has recommended that certain changes be made in Title 15 of the Bloomington Municipal Code entitled "Vehicles and Traffic";

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Section 15.16.020 Schedule F shall be amended to add the following:

ONE-WAY ALLEYS

<u>Alley Between</u>	<u>From</u>	<u>To</u>	<u>Direction of Travel</u>
Thirteenth & Fourteenth Streets	College Ave.	100' East of College Ave.	West

SECTION II. Section 15.20.020 Schedule H shall be amended to add the following:

RESTRICTED TURNS ON RED AT SIGNALIZED INTERSECTIONS

<u>Intersection</u>	<u>From</u>	<u>To</u>
Third St. & Dunn St.	North	West
Third St. & Dunn St.	West	South

SECTION III. Section 15.24.020 Schedule I shall be amended to delete the following:

INCREASED OR DECREASED STATE SPEED LIMITS

<u>Street</u>	<u>From</u>	<u>To</u>	<u>Posted Speed</u>
Bloomfield Rd.	SR 37	250' East of Ransom Lane	45 M.P.H.
Bloomfield Rd.	250' East of Ransom Lane	Adams St.	40 M.P.H.
SR 46	750' East of Reisner Dr.	East Corporate Limit	45 M.P.H.


SECTION IV. Section 15.24.020 Schedule I shall be amended to add the following:

INCREASED OR DECREASED STATE SPEED LIMITS



SECTION V. This Ordinance shall be in full force and effect from and after its passage by the Common Council of the City of Bloomington and approval of the Mayor.




