

TO VACATE A PUBLIC PARCEL RE: AN EAST/WEST ALLEY  
EAST OF MORTON STREET BETWEEN LOTS 10 & 11 OF HUNTER ADDITION  
(INDIANA UNIVERSITY, PETITIONER)

WHEREAS, IC 36-7-3-12 authorizes the Common Council to vacate public ways and places upon petition of persons who own or are interested in lots contiguous to those public ways and places; and

WHEREAS, the petitioner has filed a petition to vacate a parcel of City property more particularly described below:

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Through the authority of IC 36-7-3-12, a portion of City-owned property, to-wit the east/west alley east of Morton Street running between lots 10 & 11 of Hunter Addition, being 12' x 132', shall be vacated. The property is more particularly described as follows:

A Twelve (12.00) foot alley running East and West along the North line of Lot No. 10 in Hunter Addition in Monroe County, Indiana, described as follows: Beginning at a point on the Northwest corner of Lot 10 in Hunter Addition as recorded in the Office of the Recorder, Monroe County, Indiana, thence East over and along the North line of Lot 10 for a distance of 132 feet to the Northeast corner of Lot 10, thence North 12 feet to the Southeast corner of Lot 11 in Hunter Addition thence West 132 feet to the Southwest corner of Lot 11, thence South 12 feet to the point of the beginning of this description. Said parcel being approximately .036 acres in area.

SECTION II. This ordinance shall be in full force and effect from and after its passage by the Common Council of the City of Bloomington and approval by the Mayor.
