RESOLUTION 89-8

TO EXPRESS COMMON COUNCIL SUPPORT FOR AN ADJUSTMENT TO THE PLAN COMMISSION FEE SCHEDULE

- WHEREAS, the present Plan Commission fee schedule was established in September, 1979; and
- WHEREAS, the cost of providing City services has increased dramatically since the present fee schedule was established; and
- WHEREAS, where the City provides these services which benefit individual petitioners, as well as the community as a whole, the individual petitioners should pay a fair share of the full cost of the services delivered; and
- WHEREAS, the full cost of services includes direct costs such as labor, departmental supervision and administration, supplies and materials; and
- WHEREAS, the full cost of services also includes indirect costs such as allocated costs of budgeting, accounting, personnel, purchasing, legal and other support functions, as well as building occupancy and incidental employee benefits; and
- WHEREAS, although indirect costs cannot always be specifically identified with specific services, such costs are necessary to support the operations of a department or the City as a whole; and
- WHEREAS, adjustments in the fee schedule would reduce the extent of the governmental subsidy required from the City's General Fund for these services by reducing the cost to revenue ratio; and
- WHEREAS, a reduction in the City's subsidy of these costs would be more equitable because those who use the services would bear a greater portion of the cost of those services; and
- WHEREAS, many cities and counties across the state and nation have increased user fees an in attempt to partially recover the cost of the services provided; and
- WHEREAS, a general survey of planning fee schedules for other Indiana cities indicate that for a rezoning request, for example, Carmel and Greenwood charge \$250, Fort Wayne charges \$100, and New Albany and Evansville charge \$50; and
- WHEREAS, the Bloomington Plan Commission will soon be reviewing the present fee schedule;

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

The Common Council expresses its support of an upward adjustment in the present Plan Commission fee schedule to allow the City to recover a larger percentage of the costs of the services provided. The Council also supports an increase in order to bring Bloomington into line with the fees charged by other cities, both larger and smaller, within Indiana.
