TO APPROVE INTTERLOCAL COOPERATION AGREEMENT FOR
HOUSEHOLD HAZARDOUS WASTE COLLECTION PROGRAM

WHEREAS, the City Of Bloomington is planning a one-day collection program to provide an opportunity for private citizens to dispose of household hazardous wastes; and,

WHEREAS, Monroe County desires to join in support of the financing of this program, so that all citizens of Monroe County may avail themselves of this opportunity; and,

WHEREAS, an interlocal agreement for the financing and implementation of this program is permissible under Ind. Code Sec. 36-1-7-1 et seq.

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, THAT:

The Interlocal Cooperation Agreement for Household Hazardous Hazardous Waste Collection Program, a copy of which is attached hereto and made a part hereof, is hereby approved, and the Mayor and Director of Public Works are hereby authorized to execute said agreement on behalf of the City of Bloomington.

SYNOPSIS

This Resolution approves and authorizes the Mayor and Director of Public Works to execute the Interlocal Cooperation Agreement for Household Hazardous Waste Collection Program. The purpose of this Agreement shall be the planning and implementation of a one-day program for the receipt of household hazardous wastes from private citizens who are residents of the City of Bloomington or Monroe County. This program shall be coordinated and conducted by the City of Bloomington, to occur on or about April 29, 1989. The County shall pay the City \$11,250.00 to participate in the program.

INTERLOCAL COOPERATION AGREEMENT FOR HOUSEHOLD

WHEREAS, the City of Bloomington is planning a one-day collection program to provide an opportunity for private citizens to dispose of household hazardous wastes; and

WHEREAS, Monroe County desires to join in support of the financing of this program, so that all citizens of Monroe County may avail themselves of this opportunity; and

WHEREAS, an interlocal agreement for the financing and implementation of this program is permissible under Ind. Code Sec. 36-1-7-1 et seq.

NOW, THEREFORE, the parties do mutually agree as follows:

- (1) The purpose of this Agreement shall be the planning and implementation of a one-day program for the receipt of household hazardous wastes from private citizens who are residents of the City of Bloomington or Monroe County, Indiana. The program shall be coordinated and conducted by the City of Bloomington and shall occur on April 29, 1989 at the Utilities Service Center Parking Lot, 1969 South Henderson Street.
- (2) The term of this Agreement shall be from the date of execution through thirty (30) days after the one-day program.
- (3) The overall projected costs of the program are targeted at \$23,750.00, of which the City shall contribute \$12,500.00 and the County shall contribute \$11,250.00. The money shall be expended to pay for publicity and vendor costs.
- (4) The County shall pay the City \$11,250.00 on or before May 5, 1989. Payments shall be made to the City of Bloomington, in care of the Controller. The City Environmental Projects Coordinator shall provide written budgetary update reports to the County on or before the payment date, and 30 day after the program. Payments

are subject to appropriation and approval by the County Council.
