ORDINANCE 88-1

To Vacate a Public Parcel re: an East/West Alley running from Lincoln Street West for 132 feet between Sixth and Seventh Street (First Presbyterian Church)

WHEREAS, IC 36-7-3-12 authorizes the Common Council to vacate public ways and places upon petition of persons who own or are interested in lots contiguous to those public ways and places; and

WHEREAS, the petitioner has filed a petition to vacate a parcel of City property more particularly described below:

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Through the authority of IC 36-7-3-12, a portion of City-owned property, to-wit the east and west alley running from Lincoln Street west for 132 feet and lying between Sixth and Seventh Street shall be vacated. The property is more particularly described as follows:

> LEGAL DESCRIPTION FOR THE EAST/WEST ALLEY BETWEEN IN-LOTS #235,236 AND #253,254 OF THE ORIGINAL PLAT OF THE CITY OF BLOOMINGTON

Beginning at the Southeast corner of In-lot 253 of the original plat of the City of Bloomington; thence South 12 feet to the Northeast corner of In-lot 236 of said original city plat; thence West along the North line of said Lot 236 for 66 feet to the Northeast corner of In-lot 235, thence continuing West along the North line of said In-lot 235 for 66 feet to the Northwest corner of In-lot 235; thence North 12 feet to the Southwest corner of In-lot 254 of said original city plat; thence East along the South line of said In-lot 254 for 66 feet to the Southwest corner of In-lot 253 thence continuing East along the South line of said In-lot 253 for 66 feet to the point of beginning, containing 0.036 acres, more or less.
