

ORDINANCE 88-21

To Amend Title 15 of the Bloomington Municipal Code Entitled

NOW, THEREFORE, BE IT HEREBY ORDAINED by the Common Council of
 the City of Bloomington, Monroe County, Indiana, that:

SECTION I. Section 15.24.020 Schedule I shall be amended to
 add the following:

 add the following:


SECTION Section 15.32.090 Schedule N shall be amended to
 add the following:

LIMITED PARKING ZONES

SYNOPSIS

This ordinance, requested by the Traffic Commission, makes several changes in Title 15. The speed limit on Third Street and Atwater Street from Dunn St. to Jordan Ave. is to be reduced to 25 MPH. No Parking Zones are to be added on Kirkwood in front of the library, and on Lincoln. Limited Parking Zones are to be added on Kirkwood and Walnut.
