

ORDINANCE 88-48

TO AMEND VARIOUS SECTIONS OF TITLE 15 ENTITLED  
"VEHICLES AND TRAFFIC"

WHEREAS, the Traffic Commission has recommended several changes in Title 15 entitled "vehicles and traffic";

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Section 15.12.010 SCHEDULE B shall be amended to delete the following:

MULTI-STOP INTERSECTIONS

Dunn Street & Third Street	3-Way
Lincoln Street & Third Street	3-Way
Madison Street & Third Street	4-Way

SECTION II. Section 15.12.030 SCHEDULE D shall be amended to add the following:

SIGNALIZED INTERSECTIONS

Third Street & Dunn Street  
Third Street & Lincoln Street  
Third Street & Madison Street

SECTION III. Section 15.24.020 SCHEDULE I shall be amended to add the following:

INCREASED OR DECREASED STATE SPEED LIMITS

<u>Street</u>	<u>From</u>	<u>To</u>	<u>Posted Speed</u>
SR 46	750' East of Reisner Drive	SR 446	35 M.P.H.
SR 45	SR 37	750' West of Curry Pike	40 M.P.H.

SECTION IV. Section 15.24.030 SCHEDULE J shall be amended to add the following:

SCHOOL SPEED ZONES

SECTION V. Section 15.32.030 SCHEDULE L shall be amended to add the following:

SECTION VI. Section 15.32.080 SCHEDULE M shall be amended to add the following:

NO PARKING ZONES

Indiana Ave.	Eighth St.	50' South of Eighth Street	West	Anytime

SECTION VII. Section 15.32.090 SCHEDULE N shall be amended to add the following:

LIMITED PARKING ZONES

<u>Street</u>	<u>From</u>	<u>To</u>	<u>Side of Street</u>	<u>Limit</u>
College Ave.	177' South of 17th St.	132' South of 17th St.	West	2 Hr. (6)

SECTION VIII. Severability. If any section of this ordinance or any part of any section shall be declared invalid or unconstitutional such declaration shall not affect the validity or constitutionality of the remaining portions.

SECTION IX. This Ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.

Specifically, it adds three signalized intersections, a school zone, a no parking zone, a limited parking zone and a change in the state speed limit. The request for angle parking did not receive Traffic Commission approval. The ordinance also deletes multi-stop intersections where the signalized intersections are to be added.
