

ORDINANCE 87-7

To Amend Title 15 of the Bloomington Municipal Code Entitled "Vehicles and Traffic" (Misc. Traffic Amendments)

WHEREAS, The Bloomington Traffic Commission has met and recommended certain changes in Title 15 of the Bloomington Municipal Code Entitled "Vehicles and Traffic ":

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT THE FOLLOWING SECTIONS IN TITLE 15 OF THE BLOOMINGTON MUNICIPAL CODE SHALL BE AMENDED TO READ AS FOLLOWS:

Section I. Section 15.32.100 Loading Zones Schedule O shall be amended to add the following:

200 Block of North Madison, first space north of Sixth Street on West Side.

300 Block of South Lincoln on the east side, 30 feet north of the east/west alley south of Third Street.

Section II. Section 15.32.090 Limited parking Zones Schedule N shall be amended to change:

Section III. Section 15.12.030 Yield Intersections--Schedule C shall be amended to add the following:

Traffic on Poplar Court shall Yield to traffic on Poplar Drive

Section IV. Section 15.12.030 Yield Intersections Schedule C shall be amended to delete the following:

Traffic on Kensington shall yield to traffic on Wexley

Section V. Section 15.32.080 No parking zones--Schedule M shall be amended to add the following:

Ninth	Fairview St.	First alley East	South	Anytime

Section VI. Section 15.32.090 Limited parking zones--Schedule N shall be amended to change:

Section VII. Section 15.12.010 Stop Intersections Schedule A shall be amended to delete the following:

Traffic on Caradon Hill shall Stop for traffic on Wexley Road

SECTION VIII. This ordinance shall be in full force and effect from and after its passage by the Common Council of the City of Bloomington and approval by the Mayor.

SYNOPSIS

This Ordinance makes several changes in Title 15 of the Municipal Code as recommended by the Bloomington Traffic Commission: Adds two loading zones; deletes a stop for a yield at Caradon Hill & Wexley Rd.; adds and deletes two yield signs; adds a no-parking zone on 9th Street between Fairview and the east alley, and deletes a no-parking zone on Washington between 7th and 8th streets; and changes limited parking on Dunn to between 4th and 6th streets.
