

ORDINANCE 87-16

To Amend Various Sections of the Bloomington Municipal Code  
(Correcting Provisions for Title of Board of Park Commissioners, City  
Standard for Street Repairs, Title 15 penalty provisions, and Section  
16.04.010 of the Housing Code)

WHEREAS, There are certain corrections in the Bloomington Municipal  
Code which should be made in order to bring the Code into  
compliance with current procedures:

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF  
THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

Section I. The following Sections of Title 2 of the Bloomington  
Municipal Code shall be amended so that "Bloomington and Monroe  
County Board of Park Commissioners" shall read "Bloomington Board of  
Park Commissioners" where such appears in Title 2:

Title 2--Index-listing for Chapter 2.20

Chapter 2.20--Title

Section 2.20.00--second sentence

Section 2.20.010--first sentence

Section 2.20-130--approval of "Board of Park Commissioners"

Section II. Title 17, Section 17.08.080(1) Diagram of "City  
Standard for Street Repairs" shall be amended to delete Diagram  
dated 6/82 and to add Diagram attached hereto and made a part hereof.

Section III. Title 15, Sections 15.64.101(d) and 15.64.010(e)  
shall be amended as follows:

15.64.010(d), "Class D Traffic Violations" shall be amended to  
add the following:

- 15.32.010 - Parking Adjacent to Yellow Curb
- 15.32.170 - Parking in Municipal Lot #5 during Farmer's Market
- 15.32.180 - Parking facing traffic

15.64.010(e), "Class E Traffic Violations" shall be amended to  
add the following:


- 15.56.060 - Removing license decal from bicycle

Section IV. Title 16, Section 16.04.010 - PM -302.1, paragraph 3,  
shall be amended to read as follows:

"Where the Code Official has ordered repairs to correct  
exterior violations other than painting, an extension of time  
to complete the repairs may be granted for a period not to  
exceed one year from the date that the inspection report and  
order are mailed; provided, no such extension shall be granted  
where, in the opinion of the Code Official, the violations are  
~~not~~ life-safety in nature."

Section V. This ordinance shall be in full force and effect  
from and after its passage by the Common Council of the City of  
Bloomington and approval by the Mayor.

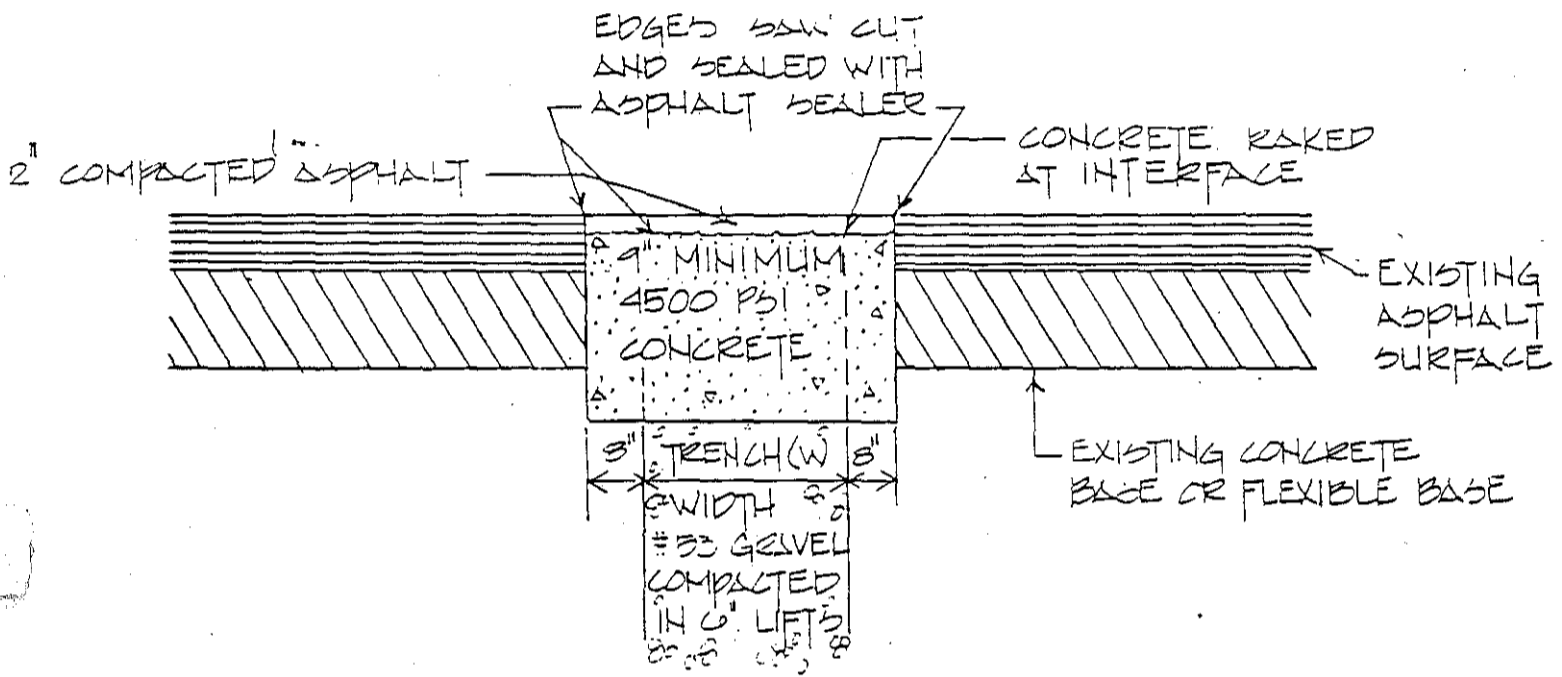
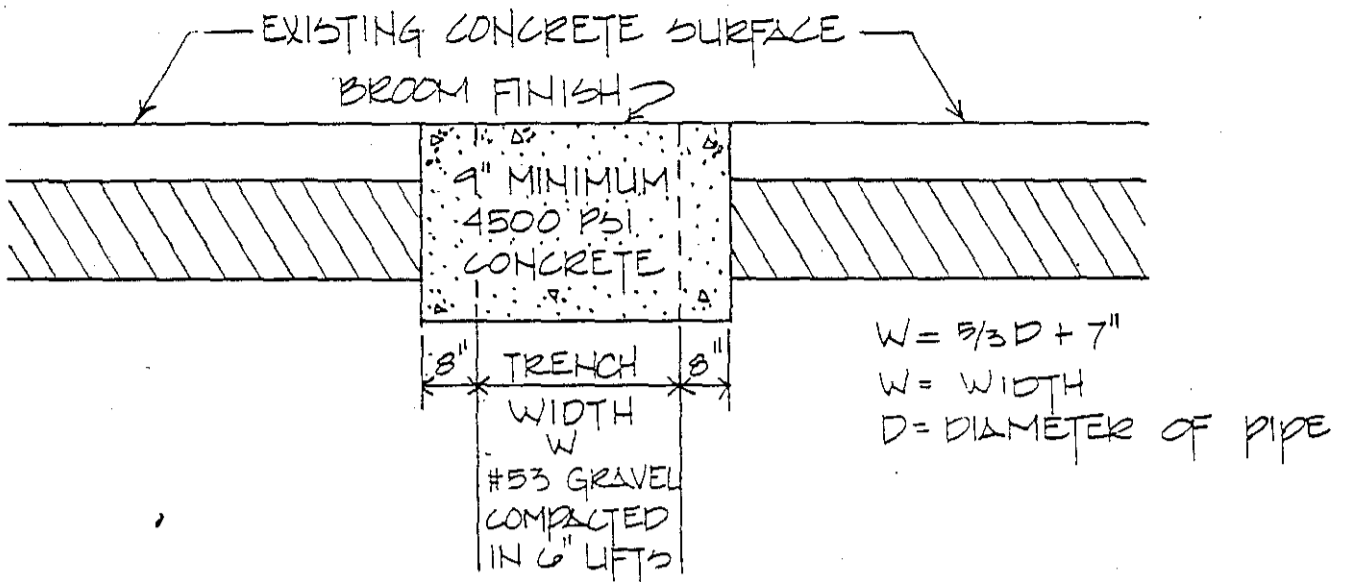

#### SYNOPSIS

This Ordinance corrects current Title 2 of the Bloomington Municipal Code to read "Board of Park Commissioners" in lieu of "Bloomington and Monroe County Board of Park Commissioners"; it also corrects the Diagram for City Standard for Street Repairs contained in Section 17.08.080(1), adds certain traffic violations to the penalty list in Title 15 "Vehicles and Traffic", and corrects an error in Section 16.04.010 "Housing Code."
