

To Amend Title 15 and Title 2 of the Bloomington Municipal Code
Entitled "Vehicles and Traffic" and "Administration and
Personnel"

WHEREAS, The Bloomington Traffic Commission has met and recommended certain changes in Title 15 and Title 2 of the Bloomington Municipal Code:

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT THE FOLLOWING SECTIONS IN TITLE 15 AND TITLE 2 OF THE BLOOMINGTON MUNICIPAL CODE SHALL BE AMENDED TO READ AS FOLLOWS:

SECTION I. Section 15.32.100 Loading Zones Schedule O shall be amended to ADD the following:

400 Block of West Prospect Street, on the North Side, the first space east of Rogers Street

SECTION II. Section 15.12.010 Schedule B "Multi-Stop Intersections" shall be amended to ADD the following:

Walnut Street Pike and Winslow Road 4-Way

SECTION III. Section 2.12.070 Traffic Commission (2) Appointments shall be repealed and reenacted to read as follows:

(2) Appointments. The commission shall consist of the following nine members: a designee of the Traffic Engineer, a designee of the Director of Transportation, a designee of the Chief of Police and six additional members who shall be appointed by the Common Council. All terms shall be for two years.

SECTION IV. Section 15.24.020 Increased or Decreased State Speed Limits--Schedule I shall be amended to add the following:

Street	From	To	Posted Speed
SR46	College Mall Rd.	750' East of Reisner Drive	35 mph
SR46	750' East of Reisner Drive	E. Corporate Limit	45 mph

and to delete the following:

Third St.	College Mall Rd.	Pleasant Ridge Rd.	35 mph
Third St.	Pleasant Ridge Rd.	E. Corporate Limit	45 mph

SECTION V. This ordinance shall be in full force and effect from and after its passage by the Common Council of the City of Bloomington and approval by the Mayor.

SYNOPSIS

This Ordinance amends Title 15 and Title 2 of the Bloomington Municipal Code to add a loading zone at the 400 block of West Prospect Street for an adult day care facility at 325 South Rogers; to add a 4-way stop at the intersection of Walnut Street and Winslow Road; and to eliminate the district residency requirement for appointment to the Traffic Commission.
