ORDINANCE 13-10

**TO AMEND TITLE 15 OF THE BLOOMINGTON MUNICIPAL CODE
ENTITLED "VEHICLES AND TRAFFIC"**

**- Re: Stop and Signalized Intersections, One Way Streets, Speed Zones, Angle
Parking, No Parking, Limited Parking, Residential Neighborhood Permit Parking,
Accessible Parking and the City Parking Garages**

WHEREAS, the Traffic Commission has recommended certain changes be made in
Title 15 of Bloomington Municipal Code entitled "Vehicles and
Traffic;"

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL
OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION 1. Section 15.12.010 Schedule A shall be amended to delete the following:

SECTION 16. Section 15.40.010 Locations subsection (2) shall be amended by deleting the existing subsection and replacing it with the following:

(2) Lot 2: Walnut Street Garage: located at 300 North Walnut Street.

SECTION 17. Section 15.40.010 Locations subsection (6) shall be amended by deleting the existing subsection and replacing it with the following:

(6) Lot 7: Morton Street Garage: located at 208 North Morton Street.

SECTION 18. Section 15.40.010 Locations subsection (7) shall be amended by deleting the existing subsection and replacing it with the following:

(7) Lot 9: Fourth Street Garage: located at 105 West Fourth Street.

SECTION 19. Section 15.40.020 Schedule V shall be amended by deleting the words "Garage Band" and replacing them with "Walnut Street Garage;" by deleting the words "Garage Market" and replacing them with "Morton Street Garage;" and deleting the words "Garage Art" and replacing them with "Fourth Street Garage."

SECTION 20. Section 15.40.020 Schedule W shall be amended by deleting the words "Walnut Center Garage (7th & Walnut)" and replacing them with "Walnut Street Garage;" by deleting the words "Regester Parking Garage (7th and Morton)" and replacing them with "Morton Street Garage;" and deleting the words "4th & Walnut Parking Garage" and replacing them with "Fourth Street Garage."

SECTION 21. Section 15.34.060 Penalties shall be amended by deleting subsection (a) as it appears and replacing it with the following:

(a) A violation of Section 15.34.040(a), (b), or (c) of this chapter is a Class B traffic violation and is subject to the penalty listed in Section 15.64.010(b). Each day that a violation continues shall constitute a separate offense.

SECTION 22. Section 15.64.010 Violations and penalties shall be amended by moving the following entry from subsection (c) to subsection (b):

15.34.040 Parking illegally in an accessible parking space for persons with disabilities


SECTION 23. If any section, sentence or provision of this ordinance, or the application thereof to any person or circumstances shall be declared invalid, such invalidity shall not affect any of the other sections, sentences, provisions or applications of this ordinance that can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared to be severable.

SECTION 24. This ordinance shall be in full force and effect from and after its passage by the Common Council of the City of Bloomington and the approval of the Mayor.

SYNOPSIS

This ordinance makes several changes to the Bloomington Municipal Code. This includes stop intersections, multi-stop intersections, signalized intersections, one-way streets, school, park and playground speed zones, angle parking, no parking zones, limited parking zones, accessible parking for persons with physical disabilities, neighborhood permit parking locations, and changing the name of the three City parking garages.

The Council adopted Am 01 to this legislation that inserted two new sections (Sections 21 and 22) which amended BMC sections 15.34.060 (a) and 15.64.010 (b) and (c) to bring fines for violations of the accessible parking regulations in line with a recent change in State law.
