## ORDINANCE 8**5 -** 7

To Amend the Zoning Map from RE to BA RE: (100 blk. E. Rhorer Road) Wm. Nicholson

WHEREAS,

the Common Council passed a Zoning Ordinance amendment and adopted new incorporated zoning maps on June 7, 1978 which are now incorporated in Title 20 of the Bloomington Municipal Code; and

WHEREAS,

the Plan Commission has considered this case, ZO-100-85, and recommended that the petitioner, William Nicholson, be granted an amendment to the Bloomington zoning maps and request that the Common Council consider their petition for rezoning of certain property;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Through the authority of IC 36-7-4 that the zoning be changed from RE to BA for property located at 100 blk. of E. Rhorer Road and more particularly described as follows:

The southernmost 207' of the following described parcel: A part of the northeast quarter of the northwest quarter of section Twenty-One (21), Township eight (8) North, Range one (1) West, in Monroe County, Indiana, bounded and described as follows, to wit: Beginning at a point eight hundred eighty-three and five tenths (883.5) feet west of the northeast corner of said quarter quarter; running thence south three (3) degrees fifteen (15) minutes east for a distance of four hundred thirty-five (435) feet; thence running west for a distance of one hundred (100) feet; thence running north three (3) degrees fifteen (15) minutes west for a distance of four distance of one hundred the north line of said quarter quarter; thence running east for a distance of one hundred the north line of said quarter quarter; thence running east for a distance of one hundred the north line of said quarter quarter; thence running east for a distance of one hundred (100) feet and to the place of beginning.

SECTION II. This ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.
