ORDINANCE 86 - 56

To Amend the Bloomington Zoning Maps From RM to BL RE: SE Corner Grimes & Rogers (IU Foundation)

the Common Council passed a Zoning Ordinance amendment and adopted new incorporated zoning maps on June 7, 1978 which are now incorporated in Title 20 of the Bloomington Municipal Code; and

SECTION I. Through the authority of IC 36-7-4 that the zoning be changed from RM to BL for property located at the Southeast Corner of Grimes and South Rogers and more particularly described as follows:

Lot Number Fourteen (14) in Dodds Addition to the City of Bloomington, Indiana, as shown by the recorded plat thereof.

SECTION II. This ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.
