

ORDINANCE 86 - 58

To Vacate a Public Parcel

RE: alley located in the Block bounded by Third St.,
Rogers St., Jackson St., and Prospect (Bill Sturbaum)

WHEREAS, IC 36-7-3-12 authorizes the Common Council
to vacate public ways and places upon petition
of persons who own or are interested in lots
contiguous to those public ways and places;
and

WHEREAS, the petitioner, Bill Sturbaum, has filed a
petition to vacate a parcel of City property
in the block bounded by Third Street, Jackson
Street, Rogers Street, and Prospect;

NOW, THEREFORE BE IT HEREBY ORDAINED BY THE
COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY,
INDIANA, THAT:


SECTION I. Through the authority of IC 36-
7-3-12, a portion of City-owned property located in the
block bounded by Third Street, Jackson, Street, Rogers Street,
and Prospect shall be vacated. The property is more particularly
described as follows:

an alley owned by the City of Bloomington, lying adjacent
to and west of Lots 1 and 3 of Prospect Hill Addition to
the City of Bloomington, Indiana, more particularly described
as follows:


Beginning at the Northwest corner of Lot #1 of Prospect
Hill Addition, and running thence South along the west line
of said Lot for 65 feet, to the Southwest corner of the
lot; thence continuing South along the west line of Lot
#3 for 66 feet to the Southwest corner of Lot #3; thence
West for a distance of 14 feet to the Southeast corner of
Lot #4; thence North along the east line of Lot #4 for 66
feet to the Northeast corner thereof; thence continuing
North along the east line of Lot #2 for 65 feet to the Northeast
corner of Lot #2; thence east for a distance of 14 feet
to the place of beginning; containing in all 1834 square
feet.

SECTION II. This ordinance shall be in full
force and effect from and after its passage by the Common
Council, approval by the Mayor, and published according
to law.
