

ORDINANCE 86-61

To Amend Title 15 of the Bloomington Municipal Code Entitled "Vehicles and Traffic" (Misc. traffic changes)

WHEREAS, the Bloomington Traffic Commission has recommended certain changes be made in Title 15 of the Bloomington Municipal Code entitled "Vehicles and Traffic":

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Section 15.32.080 NO PARKING ZONES-Schedule M shall be amended to add the following:

Lincoln	South curbline on Dodds	50' South	West	Anytime
14th St.	College	Walnut	South	Anytime
Morton	Drive @ 400 N. Morton	15' South	East	Anytime

SECTION II. Section 15.32.090 Schedule N shall be amended to delete the following:

Fourteenth	College	Walnut	South	2-Hour

SECTION III. Section 15.12.010-Stop Intersections-Schedule B shall be amended to add the following:

MULTI-STOP INTERSECTIONS

Second and Mitchell 4-Way Stop

and Section 15.12.010--Stop Intersections-Schedule A shall be amended to delete the following:

Second Street	Mitchell Street

SECTION IV. Section 15.12.010-Stop Intersections--Schedule A shall be amended to add the following:

Harold	Eighth Street

SECTION V.. Section 15.24.030-School Speed Zones-Schedule J shall be amended to add the following:

First	High	750' West	20 MPH
Maxwell	High	750' West	20 MPH
Wilton	High	750' West	20 MPH

SECTION VII. This ordinance shall be in full force and effect from and after its passage by the Common Council of the City of Bloomington and approval by the Mayor.

SYNOPSIS

This Ordinance, recommended by the Traffic Commission, makes the following changes in Title 15 "Vehicles and Traffic" of the Municipal Code: adds three no-parking zones (on Lincoln, 14th, and Morton Streets); adds a 4-way stop at Second and Mitchell; adds two stops at Prow & Harold Streets; and adds three school speed zones.
