ORDINANCE 85-12

To Amend Title 15 of the Bloomington Municipal Code Entitled "Vehicles and Traffic"

WHEREAS, The Bloomington Traffic Commission has recommended that certain changes be made in Title 15 of the Municipal Code entitled "Vehicles and Traffic":

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Section 15.32.090 Limited Parking Zones Schedule N shall be amended to add the following:

SECTION IV. Section 15.32.150 <u>Handicapped Parking Spaces</u> Schedule S shall be amended to delete the following:

Lot 6, meter #M-1**

*From 9:00 AM to 5:00 PM except Sunday and Holiday
**Space near Bird and Acorn, in the Municipal Building parking lot

(b) Section 15.32.150 <u>Handicapped Parking Spaces</u> Schedule S shall be amended to add the following:

Bloomington Housing Authority (1007 N. Summit)—one space <u>limited</u> to 30 minutes between 7:00 a.m. and 6:00 p.m. except Sundays and Holidays.

Glenn Black and Mathers Museum (9th and Fess)—two spaces located on 9th Street, the first space on each side of the street west of Fess.

SECTION V. Section 15.32.100 <u>Loading Zones</u> Schedule O shall be amended to add the following:

308 N. Morton Street

SECTION VI. Section 15.24.020 <u>Increased or decreased state speed</u> <u>limits</u> Schedule I shall be amended to <u>delete</u> the following:

SECTION VII. Section 15.32.170 Courthouse Square parking during market season shall be repealed and reenacted to read as follows:

15.32.170 Municipal Parking Lot 5 parking during market season.

No person other than a registered market vendor shall park a vehicle in a parking space in Municipal parking lot 5 located at Sixth and Lincoln Streets and designated by a "No Parking" meter bag sign or other temporary sign during the hours of 6:30 A.M. through 10:00 A.M., on Saturday mornings during the market season as defined by the Human Resources Department.

Dates for the season shall be publicized throughout the community and posted in Municipal Parking Lot 5 prior to enforcement of this provision.

SECTION VIII. Section 15.32.050(a) Parking during snow removal, street repair and street cleaning shall be amended to read as follows:

(a) On-street parking shall be prohibited between the hours of 3:30 a.m. and 6:30 a.m. in the downtown area bounded by Seventh Street, Morton Street, Second Street, Washington Street, on the north and east side of the street on Monday, Wednesday and Friday; and on the south and west sides of the street on Tuesday, Thursday and Saturday.

SECTION IX. Severability. If any section, sentence, or provision of this ordinance or the application thereof to any person or circumstance shall be declared invalid, such invalidity shall not affect any of the other parts of this ordinance which can be given effect without the invalid part, and to this end the provisions of this ordinance are declared to be severable.

Section X. This Ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.

SYNOPSIS

This Ordinance makes the following changes in Title 15, "Vehicles and Traffic", of the Municipal Code: (1) the addition of three limited parking zones; (2) the addition of five no-parking zones and change in one no-parking zone; (3) the elimination of a 3-way stop at Indiana Avenue and Fifteenth Street; (4) the deletion of one and addition of two handicapped parking spaces; (5) the addition of a loading zone at 308 N. Morton; (6) increase of the speed limit on College between Dodds St. and 3rd St. to 30 MPH; (6) revision of no parking provisions for the Farmer's Market during market season due to the change in market location and (7) modification of the no-parking downtown provision to allow parking on alternate sides of the street between 3:30 a.m. and 6:30 a.m..
